PARTICIPANT AGREEMENT, RELEASE AND ACKNOWLEDGEMENT OF RISK

EVENT: The Great Youth Celebration / The Diocese of Central Florida
DATE: Saturday, February 25, 2006

In consideration of the services of The Diocese of Central Florida; Trinity Prep School; Party Guys; their agents owners, officers, volunteers, participants, employees and all other persons or entities acting in any capacity on their behalf, I hereby agree to release and discharge the above listed entities, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows.

1. I acknowledge that the event entails known and unanticipated risks which could result in physical or emotional injury paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply can not be eliminated without jeopardizing the essential qualities of the activity.
2. The risks include, among other things: Inherent and extraordinary risks involved in said event, in the use of suits, vest, helmets, gloves and/or special devices, and any risks inherent in any other activities connected with this event in which I am voluntarily participating.
3. Furthermore, The Diocese of Central Florida; Camp Trinity Prep School; Party Guys; employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be ignorant of a participant's fitness or abilities. They may give inadequate warnings or instructions, and the equipment being wet might malfunction.
4. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participating in this activity is purely voluntary, and I elect to participate in spite of the risks.
5. I hereby voluntarily release, forever discharge and agree to indemnify and hold harmless The Diocese of Central Florida; Trinity Prep School; Party Guys from any and all claims, demands or causes of action, which are in any way connected with my participation in this activity or my use of the equipment or facilities, including any such claims which allege negligent acts or omissions of The Diocese of Central Florida; Party Guys.

6. Should The Diocese of Central Florida; Trinity Prep School; Party Guys or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
7. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly, by any such condition.

By signing this Document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against The Diocese of Central Florida; Trinity Prep School; Party Guys on the basis of any claim from which I have released them herein.
9. I have had sufficient opportunity to read this entire document I have read and understood it, and I agree to be bound by its terms. I understand that this event is a physical sport and that physical injury may result
